TIRE SERVICE REQUEST FORM DID-45 ALL MODELS

In the event a tire complaint condition, or guarantee adjustment, cannot be handled by the dealer, a "Tire Service Request" (Form DID-45) should be submitted to the tire manufacturer with two copies to the British Leyland Motors Inc. Distributor.

This Tire Service Request is to be used ONLY after the dealer has performed all normal tire service corrective methods and/or when the local tire dealer is unable to assist further.

Attached are three copies of the Tire Service Request form, and additional copies are available through your British Leyland Motors Inc. Distributor.
